2017 POOL RULES

- 1. Current 2017 Season permanent resident photo ID badges and/or approved current season 2017 tenant photo ID badges are required for admittance beyond the pool gate into the general pool area, even if you are not swimming. This includes the pool deck areas surrounding the main and kiddie pools as well as the lounge chairs and umbrella tables inside the pool gate. Guests must be accompanied by the sponsor resident with the proper pool ID badges in order to enter the pool area, and the sponsor resident must remain with their guest at all times. There is no admittance to the pool area unless a lifeguard is on duty.
- Children under the age of 12 years must be accompanied by their parent or legal guardian (an adult is someone over the age of 18 years who is a resident of Glenmont Commons) at all times. Children under 5 years of age must wear a flotation device (Ex: floatation vest) and have a parent in the pool with them at all times. Disabled people are permitted to use a floatation device if needed to enjoy the pool. Parents and guardians are to be considerate of other residents enjoying the pool and keep children's noise to a reasonable level.
- 3. Food is not permitted in the pool area. Non-alcoholic beverages are permitted, however, not in glass containers. Alcoholic beverages are strictly prohibited.
- 4. Tables, chairs and lounges cannot be reserved in advance, nor held once you depart the pool area.
- 5. Only bathing suits are permitted in the pool. Cutoffs are not considered bathing suits. Children wearing diapers/pull-ups must have the diapers covered by rubber pants.
- 6. NO flotation devices are permitted (except as provided in Rule 2) NO noodles, inner tubes, rafts, diving toys, water guns, balls, Frisbees, toys, or rafts of any kind are permitted in the pool or pool area.
- 7. No diving, running around the pool area, horseplay, or jumping in the pool is allowed.
- No boom boxes or radios with speakers are allowed, unless headphones are utilized.
- 9. No pets are allowed in the pool area or the pool house.
- 10. Any person showing evidence of a communicable disease or condition may be denied admission to the pool at the lifeguard's discretion.
- 11. The lifeguard will have the final say as to whether the pool will be open or closed during inclement weather.
- 12. Smoking is not permitted in or around the pool area and veranda. This includes all cigarettes, cigars and pipes. If you wish to smoke, you must exit the pool area.
- 13. The lifeguard on duty has the final say on pool ID acceptance and admittance, and has the undisputed authority to remove any residents, tenants, and/or guests who are in violation of said rules and regulations, or of creating an unsafe or disrespectful situation in the pool area.

VIOLATION OF THESE RULES MAY RESULT IN THE SUSPENSION OR REVOCATION OF POOL PRIVILEGES.
